**Proclamation No. 124/ 2007**  
**A Proclamation to Amend Proclamation No. 109/2006 to Provide for Extension of Election Time of Members of District and Kebele Council**

**WHEREAS,** it was stated Proclamation No. 108/2006 A Proclamation Issued to Amend the Revised Constitution of Oromia National Regional State that election of District and 'Kebele' Councils takes place every five years, but if there is no conducive environment the Caffee has the mandate to extend or postpone if found necessary;

**WHEREAS,** it was reached on a consensus to extend the election of Aanaa, Kebele and Urban Councils for one year in order for the parties participating to have sufficient time for preparation and succeed in the election;

WHEREAS, it was reached on a consensus for the political parties competing this year in the election to be strong, and taking their agreement in to consideration it is important for them to have sufficient preparation time for the election;

NOW, THEREFORE, in accordance with the Revised Constitution of Oromia Regional State No. 46/2001 Article 49 (3) (a) , it is hereby proclaimed as follows.

**1. Short Title**

This proclamation may be cited as "Proclamation No.124/ 2007, A Proclamation to Amend Proclama No. 109/2006 to Provide for Extension of Election Time of Members of District and Kebele Council ."

**2. Amendment**

Article 2(1) of Proclamation No. 109/ 2006 is cancelled and replaced by the following.

"Election of members of District, Urban and Kebele Administration Councils that would have been accomplished in 1999 shall be postponed to 2008."

**3. Effective Date**

This proclamation shall enter into force as of March 24, 2007.
